1. Call to Order. Meeting was called to order at 5:03 PM

- 2. **Update on Boiler Project with Paul DegliAngeli**. Paul reported Apex Plumbing and Heating was the low bidder on the project. Paul explained the various options in terms of upgrades the Trustees should consider. A discussion ensued. **Motion made by Brian, second by Donna Dolan, to install two "System 2000" boilers with new piping at a price of approximately \$28,000. All in favor 5-0.** Further discussion ensued about the vermiculite removal and attic insulation project. Paul suggested that the attic should no longer be used as storage. Paul confirmed the request for bids included air sealing.
- 3. **Treasurer's Report**. Debbie Cross presented her report. She explained the problems encountered with Quick Books. A discussion ensued. Donna mentioned Rhonda Rosand as someone who can help with QuickBooks. Debbie indicated she would follow up with Ms. Rosand. **Motion made by Brian, second by Lucy to approve the report.
